ORDINANCE NO. SP- 98 2 , S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC HOUSING PROJECT (BP BLG. 220) WITH 8-UNIT TOWNHOUSES, CONTAINING AN AREA OF FOUR HUNDRED (400) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-215968 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY SPOUSES NOEL ROBERTO & PIA MARGARITA U. ESCUETA, AND LOCATED AT LOT 6, (LRC) PCS-8124, HILLMAN STREET, FAIRVIEW SUBDIVISION, BARANGAY FAIRVIEW, QUEZON CITY, METRO MANILA, AND AS APPLIED FOR BY THE OWNERS, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

SECTION 1.
