ORDINANCE NO. SP- 969 S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH FOURTEEN (14) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF NINE HUNDRED SIXTY-SIX (966) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 125894 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 234, FLS-2696-D: LUISITO CORNER DR. VILLAREAL STS., BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG JOAN OF ARC HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of A SOCIALIZED HOUSING PROJECT (BP Blg. 220) with fourteen 14-lots, Community Mortgage Program, containing an area of Nine Hundred Sixty-Six (966) square meters, covered by Transfer Certificate of Title Numbered 125894 of the Registry of Deeds of Quezon City, and located at Lot 234, Fls-2696-D: Luisito corner Dr. Villareal Sts., Barangay Gulod, Novaliches, Quezon City, Metro Manila, as applied for by the SAMAHANG MAGKAKAPITBAHAY NG JOAN OF ARC HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
