AN ORDINANCE CONVERTING INTO RESIDENTIAL THE ONE THOUSAND (1,000) SQUARE METERS PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 13037 LOCATED AT THE SOUTH EASTERN PORTION OF THE QUEZON CITY GENERAL HOSPITAL COMPOUND PRESENTLY OCCUPIED BY THE MEMBERS OF THE SAMAHANG MAGKAKAPIT-BAHAY NG SITIO GAYA-GAYA, BARANGAY BAHAY TORO, DISTRICT I, QUEZON CITY.

WHEREAS, one of the main thrusts of the Quezon City government is to provide shelter/houses to its poor constituents;

WHEREAS, the South Eastern portion consisting, more or less, one thousand (1,000) square meters that is being occupied by, more or less, fifty (50) families for almost twenty-seven (27) years, is a part of the thirteen thousand four hundred fifty-four (13,454) square meters of Quezon City General Hospital Compound;

WHEREAS, Resolution No. SP-1272, S-99, a resolution segregating the one thousand (1,000) square meter lot from the Quezon City General Hospital Compound for eventual sale to its present occupants and bonafide members of the Samahang Magkakapit-bahay ng Sitio Gaya-Gaya was passed and approved on September 28, 1999 by the Quezon City Council;

WHEREAS, the present occupants and the bonafide members of the Samahang Magkakapit-bahay ng Sitio Gaya-Gaya, thru its President, Mr. Roque Nerio, have expressed their willingness to pay at reasonable and affordable price the lot they are occupying;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby converted into residential the one thousand (1,000) square meter parcel of land covered by Transfer Certificate of Title No. 13037 located at the south eastern portion of the Quezon City General Hospital Compound, Sitio Gaya-Gaya, Barangay Bahay Toro, District I, Quezon City.
