ORDINANCE NO. SP. 992 11, S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH EIGHTEEN (18) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF EIGHT HUNDRED FIFTY-FOUR (854) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 130296 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 13, BLOCK 5, PCS-2874 PRESIDENTIAL ST., BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE PRESIDENTIAL — PIGEON HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

SECTION 1.
