ORDINANCE NO. SP-99'8 ___, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH THIRTEEN LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SEVEN HUNDRED FORTY-THREE (743) SQ. MTS. COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-83770 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 597-O, FLS-2382-D, ASUNCION STREET, JOAN OF ARC, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG JOAN ARC HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
