ORDINANCE NO. SP-1006, S-2001

AN ORDINANCE AUTHORIZING THE HONORABLE ISMAEL A MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SEGREGATE TO THE QUALIFIED MEMBERS OF SAMAHANG MAGKAKAPIT-BAHAY SAN JOSE II, INC., THE ONE THOUSAND SEVEN HUNDRED THIRTY-SIX (1,736) SQUARE METER PORTION OF THE FORMER QUEZON CITY SOCIALIZED HOUSING PROJECT AT SITIO CHAPEL, SAN JOSE VILLAGE, SEMINARY ROAD, BARANGAY BAHAY TORO, THIS CITY, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 25242, 25243, 25168, 25169, 25170, 25167, AND 25238.

WHEREAS, the City government owned a certain government lot at Sitio Chapel, San Jose Village, Seminary Road, Barangay Bahay Toro, this City;

WHEREAS, the present occupants of said lot at the northern portion of lot 3 (Pcs-13-002481) have been residing thereat for more than fifteen (15) years;

WHEREAS, Resolution No. SP-1280, S-99, authorizes the Hon. Ismael A. Mathay, Jr., City Mayor, Quezon City, to award to the qualified occupants of the northern portion of lot 3;

WHEREAS, a consolidation of subdivision plan of Lots 1&2 Block 14, Lot 3 Block 12, Lot 3 Block 11, Lots 2, 3 & 4 Block 13, and Road Lots 10, 12, 14 & 15, all Psd-13-015037 were signed by Honorable Ismael A. Mathay Jr., City Mayor, Quezon City, and segregating a portion of Lot 1 consisting of One Thousand Seven Hundred Thirty-Six square meters (1,736 sq. m.).
