ORDINANCE NO. SP- T015 -8-2001

AN ORDINANCE ALLOCATING CERTAIN PORTIONS OF THE PARCEL OF LAND OWNED BY THE QUEZON CITY GOVERNMENT AND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RI-28528 (83123) LOCATED AT BARANGAY TALIPAPA, QUEZON CITY, TO BE USED AS THE SITE OF THE BARANGAY TALIPAPA PEOPLE'S CIVIC CENTER POLICE STATION 3 HEADQUARTERS, NEW TALIPAPA HEALTH CENTER AND TALIPAPA FIRE SUB-STATION.

WHEREAS, the Barangay Council of Brgy. Talipapa. Quezon City, in its Resolution No. 431, S-2000, copy attached, urged the City Council of Quezon City to allocate portions of the parcel of land owned by the Quezon City government and covered by Transfer Certificate of Title Numbered RT-28528 (83123) located at Talipapa, Quezon City, to be used as the site of the Barangay Talipapa People's Civic Center, Police Station 3 Headquarters, New Talipapa Health Center and Talipapa Fire Sub-Station;

WHEREAS, Paragraph 2, Section 458 of the Local Government Code grants to the City Council the power to generate and maximize the use of resources:

NOW. THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Portions of the parcel of land owned by the Quezon City government and covered by Transfer Certificate of Title Numbered 28528 (83123) located at Barangay Talipapa, Quezon City, are hereby allocated to be used as the site of the following buildings, to wit:

- 1.) Barangay Talipapa People's Civic Center 400 ${

- 2.) Police Station 3 Headquarters 78sq.m.
- 3.) New Talipapa Health Center 70 sq. m. and
- 4.) Talipapa Fire Sub-Station- 18 sq. m.
