ORDINANCE NO. SP-1029-S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FAIRVIEW PARK HOMES - PAXTON (2-STOREY TOWNHOUSES WITH 96-LOTS), CONTAINING AN AREA OF SEVEN THOUSAND SEVEN HUNDRED THIRTY-SEVEN (7,737) SQ. MTS., COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-32875 (181361) RT-32878, RT-32880, RT-32882, RT-32883, RT-32884 & RT-32886 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT PAXTON CORNER DUNHILL STS., FAIRVIEW PARK SUBDIVISION, BARANGAY FAIRVIEW, QUEZON CITY, METRO MANILA, AND OWNED BY THE GOVERNMENT SERVICE INSURANCE SYSTEM, AS APPLIED FOR BY THE COLLECTIVE PROJECT MANAGEMENT, INC., WITH OFFICE ADDRESS AT THE 5/F EVEKAL BLDG., NO. 855 ARNAIZ AVENUE, LEGASPI VILLAGE, MAKATI CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of FAIRVIEW PARK HOMES - PAXTON (2-Storey Townhouses with 96-lots), containing an area of Seven Thousand Seven Hundred Thirty-Seven (7,737) sq. mts., covered by Transfer Certificates of Title Numbered RT-32875 (181361), RT-32878, RT-32880, RT-32882, RT-32883, RT-32884 & RT-32886 of the Registry of Deeds of Quezon City, located at Paxton corner Dunhill Sts., Fairview Park Subdivision, Barangay Fairview, Quezon City, Metro Manila, and owned by the GOVERNMENT SERVICE INSURANCE SYSTEM, as applied for by the COLLECTIVE PROJECT MANAGEMENT, INC., with office address at the 5/F Evekal Bldg., No. 855 Arnaiz Avenue, Legaspi Village, Makati City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
