ORDINANCE NO. SP-7033, S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF MONTGOMERY PLACE, PHASES 2, 3 AND 4 (249 LOTS WITH 2 AND 3-STOREY TOWNHOUSE UNITS), CONTAINING AN AREA OF FORTY-TWO THOUSAND ONE HUNDRED FIFTY-SIX (42,156) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-220422 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY AYALA LAND, INC., AND LOCATED AT BLOCK 16, PCS-00-009555, E. RODRIGUEZ AVENUE, BARANGAY KALUSUGAN, QUEZONCITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of MONTGOMERY PLACE, Phases 2, 3 and 4 (249 lots with 2 and 3-Storey Townhouse Units), containing an area of forty-two thousand one hundred fifty-six (42,156) square meters, covered by Transfer Certificate of Title Numbered N-220422 of the Registry of Deeds of Quezon City, owned by AYALA LAND, INC., and located at Block 16, Pcs-00-009555, E. Rodriguez Avenue, Barangay Kalusugan, Quezon City, Metro Manila, as applied for by the owner, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
