ORDINANCE NO. SP. 1044 S-2001

AN ORDINANCE SEGREGATING VETERANS VILLAGE, AREAS I, II, III, IV AND V OF SITIO PINGKIAN FROM BARANGAY PASONG TAMO, AND AREA IX OF LUZON AVENUE FROM BARANGAY OLD BALARA TO FORM A NEW BARANGAY TO BE KNOWN AS BARANGAY BETERANO.

WHEREAS, Book III, Chapter 1, Section 385 of the Local Government Code provides that a Barangay may be created, divided, merged, abolished or its boundary substantially altered by law or by an ordinance of the sangguniang panlalawigan or sangguniang panlungsod, subject to approval by a majority of votes cast in a plebiscite to be conducted by the COMELEC in the local government unit or units directly affected within such period of time as may be determined by law or ordinance creating said barangay;

WHEREAS, on January 12, 1987, the residents and actual voters of Veterans Village, Areas I, II, III IV and V of Sitio Pingkian, Barangay Pasong Tamo, and Area IX of Luzon Avenue, Barangay Old Balara, through a Resolution, signified their intention to be segregated from their respective mother barangays to form Barangay Beterano;

WHEREAS, on August 12, 1997, the Villagers Integrated Neighborhood Organization, Inc. has adopted Resolution No. 7, S-97 requesting the Barangay Council of Pasong Tamo, District II, Quezon City, to separate Veterans Village;

WHEREAS, it is the intention of the Quezon City Council to push through with the creation of Barangay Beterano which will result into a one manageable barangay thereby enhancing the delivery of basic services to the residents.

## NOW, THERFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Veterans Village, particularly Areas I, II, III, IV and V of Sitio Pingkian and Area IX of Luzon Avenue, are hereby segregated from Barangay Pasong Tamo and Barangay Old Balara respectively, to form a new barangay to be known as Barangay Beterano.
