ORDINANCE NO. SP-1077, S-2001

AN ORDINANCE REQUIRING TRICYCLE OPERATORS ISSUED A FRANCHISE BY THE TRICYCLE FRANCHISING BOARD TO REGISTER WITH THE TRICYCLE REGULATORY UNIT WITHIN FORTY-FIVE (45) DAYS FROM ISSUE OF THE FRANCHISE, WHETHER NEW APPLICANT OR RENEWAL.

WHEREAS, the "Quezon City Tricycle Ordinance of 1992", as amended, is silent with respect to the period within which to register with the Tricycle Regulatory Unit after the issuance of the franchise by the Tricycle Franchising Board;

WHEREAS, it has been noted that a large number of those issued a franchise do not register with the Tricycle Regulatory Board, but still ply their route, thereby depriving the City government of the funds equivalent to the cost of registration and worse, denying tricycle operators who are willing to legitimize their operations, thus the necessity of the ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Tricycle operators who have been issued a franchise by the Tricycle Franchising Board, whether new franchise or renewal, shall, within forty-five (45) days from date of issue register with the Tricycle Regulatory Unit (TRU).

SECTION 2. Notice shall be given to the franchised holder who failed and refused to redeem/retrieve the "Certificate of Franchise" from the Tricycle Franchising Board, within a period of fifteen (15) days from date of issue.

SECTION 3. Failure to redeem/retrieve the "Certificate of Franchise" from the Tricycle Franchising Board within a period of thirty (30) days from mailing of notice, has deem abandoned to exercise this franchise and will "ipso-facto" open the line for new applicants.

SECTION 4. A surcharge of 25% of the franchise fee shall be collected from the operators who will register with the TRU beyond the forty-five (45) days reglamentary period.

SECTION 5. The Office of the Mayor through the Office of the Tricycle Regulatory Unit shall take charge in the implementation of this Ordinance.

SECTION 6. The TRU at least once a month shall furnish a copy of the list of operators issued a franchise, who registered with the said office.


SECTION 7. This Ordinance shall take effect immediately upon approval hereof.
