ORDINANCE NO. SP-1079, S-2001

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY TO APPEND IN THEIR THEATER ADMISSION FEE THE AMOUNT OF ONE PESO (P1.00) COVERING THE PERIOD FROM JANUARY 1, 2002 TO JANUARY 31, 2002 IN CONSONANCE WITH THE 53RD ANNIVERSARY CELEBRATION OF THE QUEZON CITY RED CROSS.

WHEREAS, the Philippine National Red Cross, Quezon City Chapter (QCRC) will be celebrating their 53rd Anniversary;

WHEREAS, QCRC has been an effective and efficient partner instrumental in delivering various services to the community, especially blood services, disaster preparedness, safety services and community health and nursing services;

WHEREAS, the QCRC is currently experiencing a very tight budget, which greatly affect their operating expenses leading to the delay of their projects and programs;

WHEREAS, the One-Peso (P1.00) appended in each admission fee ticket of movie theaters in the city will serve as operating fund of the QCRC and by this gesture, such can be regarded as a manifestation of the valuable support and recognition of the services they have rendered to the City for the past 53 years.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. All cinema owners and operators within the territorial jurisdiction of Quezon City are required to append in their theater admission fee the amount of One Peso (P1.00) covering the period from January 1 to January 31, 2002 to be remitted to the Philippine National Red Cross, Quezon City Chapter or its duly authorized representative/s.

Section 2. All proceeds of this fund drive activity shall be used solely to finance the projects and programs of the Philippine National Red Cross, Quezon City Chapter and corresponding financial report shall be submitted to the City Council fifteen (15) days after the conclusions of the said activity, for its information and guidance.

Section 3. All tax-exempt activities and measures for this year, as may be appealed by Philippine National Red Cross, Quezon City Chapter to the City Council for sponsorship enactment shall be negated by this Ordinance.
