ORDINANCE NO. SP-1092, S-2001

AN ORDINANCE REQUIRING FRANCHISE HOLDERS AND OPERATORS OF TRICYCLE WITHIN THE JURISDICTION OF QUEZON CITY TO SECURE STICKER ISSUED BY THE TRICYCLE REGULATORY UNIT TO BE POSTED CONSPICUOUSLY IN THE FRONT WIND SHIELD OF THE TRICYCLE.

WHEREAS, it has been noted and of public knowledge that despite the creation of the Tricycle Franchising Board and the implementation of policies towards Tricycle Regulations by the Tricycle Regulatory Unit, "Colorum" tricycle still rampant in almost every terminal within the Quezon City area;

WHEREAS, the operations of such Colorum Tricycle will prejudice the rights of the legitimate franchise holders or threatened the riding public of unidentified and unscrupulous tricycle operators;

WHEREAS, in order to "contain" or if not lessen the operation and to identify the "Colorums" it is imperative that there should be a distinction between a "colorum" and a "franchise-holder" tricycle.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All holders of Tricycle Franchise and registered with and Tricycle Regulatory Unit shall be required to post a sticker conspicuously in from of the front wind shield of the side car.

SECTION 2. The sticker shall be issued upon registration or renewal by Tricycle Regulatory Unit;

SECTION 3. The sticker shall bear the signature of the head of the Tricycle Regulatory Unit countersigned by the secretary of the Franchising Board.

SECTION 4. The sticker issued shall be valid for one (1) year and for reasonable fee.

SECTION 5. The sticker to be issued shall be approved by the Chairman of a Committee on Transportation and Communication.

SECTION 6. The Office of the City Mayor through the Office of the Trice Regulatory Unit shall take charge in the implementation of this ordinance, include the determination of the amount to be charged for the sticker which shall confirmed by the City Council.

SECTION 7. The funding necessary for the implementation of this ordinal shall be taken from any available funds of the office of the City Mayor.

SECTION 8. This ordinance shall take effect upon its approval.
