ORDINANCE NO. SP1 114 s-1002

AN ORDINANCE REQUIRING ANY PERSON, ASSOCIATION OR PARTY WHO WILL BE UNDERTAKING MEDICAL, DENTAL AND OTHER HEALTH MISSIONS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY TO PROPERLY INFORM THE CHIEF OF THE QUEZON CITY HEALTH DEPARTMENT AND COORDINATE SUCH UNDERTAKING WITH SAID DEPARTMENT WHICH SHALL EXERCISE SUPERVISION OVER THE SAME.

WHEREAS, for humanitarian reasons and out of the goodness of their hearts, there are various individuals, associations, groups or parties which sponsor or undertake medical and dental missions in Quezon City, particulary in the depressed areas thereof, benefiting the poor and less privileged in life;

WHEREAS, while such laudable undertakings deserve the appreciation, recognition, and deep gratitude of the officials of the city government and the people of Quezon City, yet it would appear that there is a need for the proper coordination of such activities, which partake of the nature of delivery of health service, with the Quezon City Health Department;

WHEREAS, for purposes of protecting public interest and promoting the health and general welfare of the people of Quezon City, it would appear necessary that the Quezon City Health Department should exercise general supervision over the delivery of basic health services in Quezon City through such medical, dental and other health missions by private individuals, associations or parties.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Any person, association, or party desiring to sponsor or undertake any medical, dental or other health missions within the territorial jurisdiction of Quezon City should first inform the Chief of the Quezon City Health Department, and coordinate such undertaking with said Department which shall exercise supervision over the same.

SECTION 2. The penalty of fine in the amount of One Thousand Pesos (P1, 000.00) shall be imposed upon any person, or the head of any association or party sponsoring or undertaking said medical, dental or other health mission within the territorial jurisdiction of Quezon City without first informing the Chief of the Quezon City Health Department and coordinating such undertaking with said Department which shall exercise supervision over the same in violation of Section 1 hereof.

SECTION 3. The Chief of the Quezon City Health Department shall prepare and issue the necessary guidelines for the implementation of this ordinance.

SECTION 4. This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation in Quezon City.
