AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH SIXTY (60) LOTS: COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND SEVEN HUNDRED SIXTY-FOUR SQUARE METERS AND FIFTY SQUARE DECIMETERS (2,764.50 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-220878 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 86-B-2, PSD-00-054695, SARMENTO ST., BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, NETRO MANILA, AS APPLIED FOR BY THE CHRISTIAN-MUSLIM NEIGHBORHOOD HOMEOWNERS ASSOCIATION, INC., PHASE II (CARANDANG PROPERTY), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
