AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E-BP 220) WITH EIGHTY SEVEN (87) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND TWO HUNDRED FIVE (2,205) SQUARE METERS, COVERED BY TCT NO. RT-118880 (252998) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 121-B-1-B-2-A, PSD-51680, DON JULIO GREGORIO ST., BRGY. BAGBAG, NOVALICHES, QUEZON CITY, AS APPLIED FOR BY THE PROGRESSIVE LAND HOMEOWNERS ASSOCIATION, INC. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
