PLAN SUBDIVISION APPROVING THE ORDINANCE SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E-BP 220) WITH 122 LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND EIGHT HUNDRED THIRTY-FIVE (2,835) SQUARE METERS, COVERED BY TCT NO. N-216727 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 121-B-1-B-1-B, PSD-00-054971, DON JULIO GREGORIO ST., BRGY. BAGBAG, NOVALICHES, QUEZON CITY, AS HOMEOWNERS LAND **PROGRESSIVE** THE BYFOR APPLIED ASSOCIATION, INC.
