AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 2003 IN THE TOTAL AMOUNT OF FIVE BILLION TWO HUNDRED MILLION PESOS (P5,200,000,000.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR THE YEAR 2003, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Annual Budget of the Quezon City government for Calendar Year 2003 in the total amount of FIVE BILLION TWO HUNDRED MILLION PESOS (P5,200,000,000.00) covering the various expenditures for the operation of the City government for the year 2003, is hereby approved.
