AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A TWO (2) STOREY SOCIALIZED HOUSING PROJECT WITH NINE (9) UNITS, CONTAINING AN AREA OF THREE HUNDRED FIFTY (350) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-197832 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF MARJORIE B. CADIMAS AND LOCATED AT LOT 162-B-2-B, (LRC) PSD-12073, NO. 42 LLANO ROAD, BARANGAY SANGANDAAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE VRNR REALTY AND DEVELOPMENT CORPORATION WITH OFFICE ADDRESS AT 97-D CENACLE DRIVE, SANVILLE SUBDIVISION, TANDANG SORA, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO.
