ORDINANCE NO. SP-1199, S-2002

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A TWO (2) STOREY SOCIALIZED HOUSING PROJECT WITH NINE (9) UNITS, CONTAINING AN AREA OF THREE HUNDRED FIFTY (350) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-197832 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF MARJORIE B. CADIMAS AND LOCATED AT LOT 162-B-2-B, (LRC) PSD-12073, NO. 42 LLANO ROAD, BARANGAY SANGANDAAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE VRNR REALTY AND DEVELOPMENT CORPORATION WITH OFFICE ADDRESS AT 97-D CENACLE DRIVE, SANVILLE SUBDIVISION, TANDANG SORA, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. WHEREAS, under the Local Government Code, the City Council is authorized to approve Subdivision Plans;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of a Two (2) Storey Socialized Housing Project with nine (9) units, containing an area of Three Hundred Fifty (350) square meters covered by Transfer Certificate of Title No. N-197832 of the Registry of Deeds of Quezon City, registered in the name of Marjorie B.
