ORDINANCE NO. SP-**1207**, S-2002

AN ORDINANCE AMENDING ORDINANCE NO. NC-223, S-91, PROVIDING FOR BURIAL BENEFITS TO BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING THE NECESSARY FUNDS THEREFOR, SO AS TO CHANGE THE TERMS USED AND ADJUST THE RATES PRESCRIBED THEREIN.

WHEREAS, since the time of passage and approval of Ordinance No. NC-223, S-91, in 1991, no further amendment was made by the Sangguniang Panlungsod, particularly on the rate of burial assistance given to the beneficiaries;

WHEREAS, it is only proper and realistic that the necessary adjustments be made in the rate of burial assistance considering the inflated and prevailing high cost of burial expenses as compared to the time of enactment of the mentioned ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The following terms as used in Ordinance No. NC-223, S-91, are hereby amended to wit:

- a) "Barangay Tanod Brigades" is changed to "BARANGAY SECURITY DEVELOPMENT OFFICERS" (BSDO).
- b) "Kabataang Barangay (KB)" is changed to "SANGGUNIANG KABATAAN (SK)".
