ORDINANCE NO. SP-**1210**S-2002

AN ORDINANCE GRANTING SPECIAL PERMIT TO ALLOW B-7 AMUSEMENT CORPORATION TO ESTABLISH BINGO HALL AT ROBINSON'S PLACE, QUIRINO HIGHWAY, NOVALICHES, QUEZON CITY, FOR THE PURPOSE OF HOLDING BINGO GAMES, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, B-7 Amusement Corporation is a domestic corporation duly organized and existing under and by the virtue of the laws of the Republic of the Philippines with principal office at Sto. Domingo Street, Barangay Holy Spirit, Quezon City;

WHEREAS, B-7 Amusement Corporation has a pending application with the Philippine Amusement and Gaming Corporation (PAGCOR) for the issuance of its franchise to operate bingo games may be played;

WHEREAS, B-7 Amusement Corporation seeks to operate bingo hall in Quezon City at Robinson's Place, Quirino Highway, and request this City Council to grant in its favor the corresponding permit for the purpose;

WHEREAS, under Republic Act No. 7160, the City Council has the authority to enact ordinances granting franchises, authorizing the issuance of permits or licenses, and levying taxes, fees and other charges.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. Subject to its franchise issued for the purpose by the Philippine Amusement and Gaming Corporation (PAGCOR), there is hereby granted a special permit to allow B-7 Amusement Corporation to establish bingo hall at Robinson's Place, Quirino Highway, Novaliches, Quezon City, and conduct therein bingo games.
