ORDINANCE NO. SP. 1247

AN ORDINANCE AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS - NATIONAL CAPITAL REGION (DPWH-NCR) FOR THE ADVANCE PAYMENT OF THE ACQUISITION COST OF THE ROAD RIGHT-OF-WAY (RROW) OF THE PROPOSED KALAYAAN AVENUE EXTENSION ROAD PARTICULARLY LOCATED AT THE BRIDGE APPROACH AND SERVICE ROADS (KAMIAS SIDE) IN QUEZON CITY, AMOUNTING TO EIGHT MILLION NINETY-TWO THOUSAND THREE HUNDRED NINETY-TWO PESOS AND THIRTY SEVEN CENTAVOS (P8,092,392.37) AND ANY ADDITIONAL CHARGE THAT MAY BE DUE, AND APPROPRIATING THE SAID AMOUNT THEREFOR TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE QUEZON CITY GOVERNMENT.

WHEREAS, it is necessary to expedite the clearing of structures affected by the Road Right-of-Way (RROW) of the proposed Kalayaan Avenue, Extension Bridge and its Approaches Project from Kamias Street to Ermin Garcia Street, Quezon City, which will address the daily traffic congestion problem in the area;

WHEREAS, the total cost of the advance payment for the acquisition of the Road Right-of-Way is Eight Million Ninety-Two Thousand Three Hundred Ninety-Two Pesos and Thirty Seven Centavos (P8,092,392.37) as just compensation of the structures and lot affected by the aforesaid project, with photocopy of the list of names is hereto attached as Annex "A";

WHEREAS, the advance for the RROW acquisition has become very urgent because the DPWH has no appropriate cash allotment available and in order that the clearing of structures on the subject area can immediately proceed;
