ORDINANCE NO. SP-1271, S-2003

AN ORDINANCE DIRECTING THE MARKET DEVELOPMENT AND ADMINISTRATION DEPARTMENT TO STRICTLY IMPLEMENT THE PROVISIONS OF THE QUEZON CITY MARKET CODE (ORDINANCE NO. SP-944, S-2000) AND THE REVENUE CODE (ORDINANCE NO. SP-91, S-93) ON FRANCHISING AND FRANCHISE TAX AND TO EXEMPT PUBLIC MARKETS AND SLAUGHTERHOUSES WHICH WERE EXISTING PRIOR TO THE APPROVAL OF THE MARKET CODE FROM THE REGULATORY REQUIREMENTS TO SECURE A FRANCHISE, EXCEPT FOR PAYMENT OF FRANCHISE TAX.

WHEREAS, there are reports that several public markets/slaughterhouses do not comply with the provisions of the Quezon City Market Code and the Revenue Code, particularly on franchising and payment of franchise taxes and fees;

WHEREAS, the application or the implementation of Quezon City Market Code should be pursuant to the principle that laws should have prospective/progressive effect.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Market Development and Administration Department (MDAD) is hereby directed to strictly implement the provisions of the Quezon City Market Code and the Revenue Code on franchising and payment of franchise taxes.

SECTION 2. All public markets/slaughterhouses which were existing prior to the approval of the Market Code of 2000 shall be exempted from the regulatory requirements except for payment of franchise tax and the installation of the minimum required number of restroom facilities.
