## ORDINANCE NO. SP- 1300, S-2003

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (CMP), WITH TWENTY-THREE (23) LOTS, LOCATED AT LOT 278, FLS-2696-D, VIRGINIA ST., BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MARALITA NG GULOD HOMEOWNERS ASSOCIATION, INC.
