ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL "E") BP 220 WITH SEVENTY-SIX (76) LOTS, COMMUNITY MORTGAGE PROGRAM (CMP), CONTAINING AN AREA OF THREE THOUSAND SIXTEEN (3,016) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 308244 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF LILIA D. QUITANGON, AND LOCATED AT LOT 937-B-2-B-1, LRC PSD-319108, NO. 7 FORT MAGSAYSAY STREET, LUZON AVENUE, BARANGAY HOLY SPIRIT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SUNRISE HOMEOWNERS ASSOCIATION, INC., WITH OFFICE ADDRESS AT THE SAME PROJECT LOCATION, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.
