AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF ESCOPA URBAN DEVELOPMENT PROJECT (DIRECT SALE) OF THE QUEZON CITY GOVERNMENT WITH FIVE HUNDRED FORTY-SEVEN (547) (MRB) AND MEDIUM-RISE BUILDING INCLUDING LOTS RESERVED FOR FUTURE DEVELOPMENT LOCATED AT LOT NO. 7-G-1 PSD-5133, P. GOMEZ ST., BARANGAY ESCOPA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE URBAN POOR AFFAIRS OFFICE (UPAO) REPRESENTED BY MR. RAMON T.
