ORDINANCE NO. SP-1303 S-2003

APPROVING THE SUBDIVISION ORDINANCE PLAN SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E-BP 220) WITH SIXTY-SIX (66) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF THREE THOUSAND (3,000) SQUARE METERS, COVERED BY TCT NUMBERED RT-121230 OF REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 753-A, PSD-62376, MAGNOLIA STREET, BARANGAY STA. MONICA, DISTRICT II, QUEZON CITY, AS APPLIED FOR BY STA. MONICA RIVERSIDE ASSOCIATION, INC., PHASE 1 (HI MARKETING HOMEOWNERS CORPORATION - PROPERTY), REPRESENTED BY ITS PRESIDENT, MS. ERLINDA A. MANALO, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG.220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
