ORDINANCE NO. SP-1304, $$^{1}_{2003}$

AN ORDINANCE RECLASSIFYING A PARCEL OF LAND WHICH MAY BE CONSIDERED AS AN ACCRETION/EXCESS LOT AND PREVIOUSLY CONCEIVED AND REFERRED TO IN PROPOSED ORDINANCE NO. 2002-07 AND PROPOSED RESOLUTION NO. 2002-13 AS PORTION OF EASEMENT, SITUATED BETWEEN BLOCK 14, PSD-39577 OF THE ORIGINAL SUBDIVISION PLAN AND CULIAT CREEK, BARANGAY VASRA, QUEZON CITY, AS RESIDENTIAL OR CONVERTING THE SAME PARCEL OF LAND FROM ITS ORIGINAL CLASSIFICATION TO RESIDENTIAL FOR DISTRIBUTION OR FOR SALE TO ITS INFORMAL SETTLERS THEREON.
