ORDINANCE NO. SP-1316, S-2003

AN ORDINANCE CONVERTING THE PARCEL OF LAND OF THE PORTION OF ROAD LOT 143, PSD-68807, WHICH IS OCCUPIED BY BARANGAY HALL, SANGGUNIANG KABATAAN (SK) HALL, BASKETBALL COURT, MULTI-PURPOSE HALL, DAYCARE CENTER, HEALTH CENTER. PLAYGROUND, PHILIPPINE DENTAL ASSOCIATION CENTER, TENNIS COURT AND FLORA A. YLAGAN SCHOOL LOCATED AT MALAKAS STREET, BARANGAY PINYAHAN, QUEZON CITY, COVERED BY TCT NO. RT-30115 (258278) ISSUED BY THE REGISTER OF DEEDS, AND REGISTERED IN THE NAME OF QUEZON CITY GOVERNMENT FROM THEIR CURRENT CLASSIFICATION TO AN OPEN SPACE.

WHEREAS, the portion of the Road Lot 143, PSD-68807 is currently occupied and used as the Barangay Hall of Barangay Pinyahan, Basketball Court, SK Hall, Multi-purpose Hall, Day Care Center, Health Center, Office of Senior Citizen of Pinyahan, Parks and Playground, Dental Clinic of Philippine Dental Association, Tennis Court and Flora Ylagan High School;

WHEREAS, this action was made due to the suggestion of the Legal Office of Quezon City to convert this portion of Road Lot 143, PSD-68807 to make the above establishments place permanent;

WHEREAS, the residents and organizations in Barangay Pinyahan and the Barangay Council of Barangay Pinyahan express their full support by passing the same resolution;

WHEREAS, the conversion of the aforementioned portion of the road lot from its present classification to that of open space is imperative under the aforementioned premises.
