ORDINANCE NO. SP- 1322 , S-2003

AN ORDINANCE AMENDING ORDINANCE NO. SP-756, S-99, ENTITLED, "AN ORDINANCE DONATING A PARCEL OF LAND AT PROJECT 4, BARANGAY MILAGROSA, QUEZON CITY, DESCRIBED AS LOT 1, BLOCK 82, PSD-57970, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 61383, WITH AN AGGREGATE AREA OF 20 METERS x 190 METERS (5,000 SQ.M.), MORE OR LESS, DONATED TO THE CITY GOVERNMENT BY THE NATIONAL HOUSING AUTHORITY (NHA), IN FAVOR OF BARANGAY MILAGROSA, QUEZON CITY, FOR THEIR DEVELOPMENT AS A PARK AND PLAYGROUND".

WHEREAS, on July 31, 1989, the National Housing Authority (NHA) donated to Quezon City a parcel of land identified as Lot 1, Block 82, Psd-57970, located at Barangay Milagrosa, Project 4, Quezon City, covered by and embraced in Transfer Certificate of Title Numbered 61383 of the Registry of Deeds of Quezon City, with a total area of twenty nine thousand nine hundred sixty-nine square meters and five square decimeters (29,969.5 sq.m.), more or less;

WHEREAS, on January 26, 1999, Ordinance No. SP-756, S-99 was enacted donating to Barangay Milagrosa, a component barangay of this City, a five thousand square meter (5,000 sq.m.) portion of the above-described parcel of land;
