AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP 220) WITH 281 LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIXTEEN THOUSAND TWENTY-SEVEN (16,027.00) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-235658 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 50-C-1-F, (LRA) PSD-372437, GOLDEN SHOWER STREET, GROUP 1, AREA B, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, AS APPLIED FOR BY GOLDEN SHOWER HOMEOWNERS ASSOCIATION, INC. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
