AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL "E"-B.P. 220) WITH TWENTY-SIX (26) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND (1,000) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-123484 (141044) OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF NANIE KING BELLEZA, LOCATED AT LOT 595-NEW-B-6-7-B-1-A, PSD-55419, 163 INT. BANLAT ROAD, BARANGAY TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMA-SAMA TUNGO SA PAGKAKAISA HOMEOWNERS ASSOCIATION, INC. WITH OFFICE ADDRESS AT THE SAME PROJECT LOCATION, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BILANG 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
