ORDINANCE APPROVING THE SUBDIVISION PLAN SOCIALIZED HOUSING PROJECT (MODEL "E") BP-220 WITH FIFTEEN (15) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED FOUR (504) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-151174 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF NESTOR M. EMBISAN, AND LOCATED AT LOT 2, PCS-2398, 108 SOUTH ZUZUARREGUI STREET, BARANGAY MATANDANG BALARA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE PINAG-ISANG PALAD HOMEOWNERS ASSOCIATION, INC. WITH OFFICE ADDRESS AT THE SAME PROJECT SUBJECT LOCATION, TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BILANG 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
