ORDINANCE NO. SP-1347, S-2003

AN ORDINANCE PROHIBITING PARKING OF MOTOR VEHICLES ALONG RIGOR STREET, BARANGAY MASAGANA, QUEZON CITY, EXCEPT FOR SHORT STOP FOR LOADING AND UNLOADING ONLY BY DELIVERY VANS, SCHOOL SERVICE VEHICLES AND TAXIS.

Introduced by Councilors DIORELLA MARIA SOTTO-DE LEON, JORGE L. BANAL, JULIAN M.L. COSETENG, FRANZ S. PUMAREN, WENCEROM BENEDICT C. LAGUMBAY and DANTE M. DE GUZMAN.

WHEREAS, the Sangguniang Barangay of Barangay Masagana adopted a resolution urging the Quezon City Council to enact an ordinance prohibiting the parking of motor vehicles along Rigor Street in said barangay, for the reason that said street is narrow and can hardly accommodate two vehicles going in opposite directions at the same time;

WHEREAS, the said street is allegedly used by the residents thereat as garage for their vehicles, thus, causing an obstruction to the free flow of vehicular traffic in said street;

WHEREAS, the Quezon City Council is fully vested with authority under the pertinent provisions of the Local Government Code of 1991, to regulate the use of City streets.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Parking along Rigor Street, in Barangay Masagana, Quezon City, is hereby prohibited, except for short stops for loading and unloading only by delivery vans, school service vehicles and taxis.

SECTION 2. Violation of the provision of Section 1 hereof shall be punished as provided under the Quezon City Traffic Code and other existing traffic regulations, for illegal parking in a prohibited "no parking" area.

SECTION 3. This Ordinance shall take effect fifteen (15) days after publication in a newspaper of general circulation in Quezon City.
