ORDINANCE NO. SP-1383, S-2004

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF ALTAVILLE DEVELOPMENT CORPORATION (4 LEVEL TOWNHOUSES WITH 18-UNITS), CONTAINING AN AREA OF ONE THOUSAND SIX HUNDRED SEVENTY-TWO SQUARE METERS AND FORTY SQUARE DECIMETERS (1,672.40 SQ.M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-218824 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ALTAVILLE DEVELOPMENT CORPORATION, LOCATED AT LOT 8, BLOCK 460, DAPITAN STREET, BARANGAY STO. DOMINGO, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ITS PRESIDENT, MR. ALFONSO G. SIY, WITH OFFICE ADDRESS AT NO. 42 STO. DOMINGO STREET, QUEZON CITY, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Altaville Development Corporation (4) Level Townhouses with 18-units), containing an area of One Thousand Six Seventy-Two square meters and Forty square (1,672.40 sq.m.), covered by Transfer Certificate of Title Numbered N-218824 of the Registry of Deeds of Quezon City, registered in the name of Altaville Development Corporation, located at Lot 8, Block 460, Dapitan Street, Barangay Sto. Domingo, Quezon City, Metro Manila, as applied for by its President, Mr. Alfonso G. Siy, with office address at No. 42 Sto. Domingo Street, Quezon City, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93, and PD 957, details of which are as follows:
