ORDINANCE NO. SP-**1388**, S-2004

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E-BP 220) WITH ONE HUNDRED EIGHTY-EIGHT (188) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF EIGHT THOUSAND SEVEN HUNDRED TWO (8,702) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-12851 (190367) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 1, (LRC) PCS-2807, F, CARLOS STREET, APOLONIO SAMSON, BAESA, DISTRICT II, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY F. CARLOS MENDEZ-PAJO HOMEOWNERS ASSOCIATION, INC., PHASE II (PROSPERITY INDUSTRIAL CORPORATION PROPERTY), REPRESENTED BY ITS PRESIDENT, MS. NORMA S. GAMBOA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

WHEREAS, the City Council is empowered to approve subdivision plans for residential, commercial or industrial purposes.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. The subdivision plan of Socialized Residential Housing Project (Model E-BP Blg. 220) with One Hundred Eighty-Eight (188) lots, Community Mortgage Program, containing an area of Eight Thousand Seven Hundred Two (8,702) square meters, covered by TCT No. RT-12851 (190367) of the Registry of Deeds of Quezon City, located at Lot 1, (LRC) Pcs-2807, F. Carlos Street, Apolonio Samson, Baesa, District II, Quezon City, as applied for by F. Carlos Mendez-Pajo Homeowners Association, Inc. Phase II (Prosperity Industrial Corporation-Property) represented by its President, Ms. Norma S. Gamboa, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
