AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E-BP 220) WITH ONE HUNDRED FORTY-SIX (146) LOTS, COMMUNITY MORTGAGE THOUSAND TWO PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED FORTY-EIGHT (5,248) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-12851 (190367) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 1, (LRC) PCS-2807, F. CARLOS STREET, APOLONIO SAMSON, BAESA, DISTRICT II, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY F. CARLOS MENDEZ-PAJO HOMEOWNERS ASSOCIATION, INC., PHASE (PROSPERITY INDUSTRIAL CORPORATION-PROPERTY), REPRESENTED BY IT'S PRESIDENT, MR. RONIE C. DEE, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

The subdivision plan of Socialized Residential Housing Project (Model E- BP Blg 220) with 146 lots, Community Mortgage Program, containing an area of Five Thousand Two Hundred Forty Eight (5,248) square meters, covered by TCT No. RT-12851 (190367) of the Registry of Deeds of Quezon City, located at Lot 1, (LRC) Pcs-2807, F. Carlos Street, Apolonio Samson, Baesa, District II, Quezon City, as applied for by F. Carlos Mendez-Pajo Homeowners Association, Inc. Phase III (Prosperity Industrial Corporation Property) represented by its President, Mr. Ronie C. Dee, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
