SUBDIVISION PLAN OF AN ORDINANCE APPROVING THE SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP 220) WITH SIXTEEN (16) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED EIGHTY-NINE (589) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 237470 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 735-M-4, PSD-00-053038, KABAGONG TAUHAN STREET, BARANGAY GULOD, NOVALICHES, DISTRICT II, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHAN NO NAGKAKAISANG MAGKAKAPIT-BAHAY NG KABAGONG **TAUHAN** HOA., INC. (BILANGEL PROPERTY), REPRESENTED BY ITS PRESIDENT, MIR. ARIEL A. ROA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Residential Housing Project (Model E – BP Blg. 220) with 16 lots, Community Mortgage Program, containing an area of Five Hundred Eighty-Nine (589) square meters, covered by Transfer Certificate of Title Numbered 237470 of the Registry of Deeds of Quezon City, located at Lot 735-M-4, Psd-00-053038, Kabagong Tauhan Street, Barangay Gulod, Novaliches, District II, Quezon City, Metro Manila, as applied for by the Samahan ng Nagkakaisang Magkakapit-bahay ng Kabagong Tauhan HOA, Inc. (Bilangel property), represented by its President, Mr. Ariel A. Roa, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
