APPROVING THE SUBDIVISION PLAN OF A ORDINANCE SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E- BP 220) ONE HUNDRED SIXTY-EIGHT (168) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIX THOUSAND SIX HUNDRED FIFTY EIGHT (6,658.00) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT - 12851 THE REGISTRY OF DEEDS 0FQUEZON CITY, (190367) OF PROSPERITY INDUSTRIAL IN THE NAME OF. REGISTERED CORPORATION, LOCATED AT LOT 1, (LRC) PCS-2807, F. CARLOS STREET, APOLONIO SAMSON, BAESA, DISTRICT II, METRO MANILA, AS APPLIED FOR BY F. CARLOS MENDEZ-PAJO HOMEOWNERS ASSOCIATION, INC. (PHASE IV) - PROSPERITY INDUSTRIAL CORPORATION PROPERTY, REPRESENTED BY ITS PRESIDENT, MR. DANIEL T. BOZAR, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. ## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY CONCIL OF QUEZON CITY IN SESSION ASSEMBLED;

SECTION 1. The subdivision plan of a Socialized Residential Housing Project (Model E-BP Blg. 220) with one hundred sixty-eight (168) lots, Community Mortgage Program, containing an area of Six Thousand Six Hundred Fifty Eight (6,658) square meters, covered by Transfer Certificate of Title Numbered RT-12851 (190367) of the Registry of Deeds of Quezon City, registered in the name of Prosperity Industrial Corporation, located at Lot 1, (LRC) Pcs-2807, F. Carlos Street, Apolonio Samson, Baesa, District II, Quezon City, Metro Manila, as applied for by F. Carlos Mendez - Pajo Homeowners Association, Inc., (Phase IV) - Prosperity Industrial Corporation Property, represented by its president, Mr. Daniel T. Bozar, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
