AN ORDINANCE AUTHORIZING BARANGAY KAUNLARAN, DISTRICT IV, QUEZON CITY TO USE THE DEAD-END 3RD PLANAS STREET, BARANGAY KAUNLARAN, QUEZON CITY, TOGETHER WITH THE MULTI-PURPOSE HALL ERECTED THEREIN FOR LIVELIHOOD PROGRAMS AND FOR OTHER PUBLIC PURPOSES.

WHEREAS, the Sangguniang Barangay of Kaunlaran has requested the Local Government of Quezon City to allow the use of the Multi-Purpose Hall erected at Dead-End 3rd Planas Street, Barangay Kaunlaran, Quezon City for Livelihood Programs and for other public purposes;

WHEREAS, the existence of the said Multi-Purpose Hall cannot isolate or prejudice adjacent real properties as there is an existing road right-of-way for the use of the general public;

WHEREAS, to date, the said Multi-Purpose Hall houses Daycare Center wherein thirty (30) pupils were enrolled in the morning and twenty-five (25) pupils in the afternoon and likewise it is the gathering place of the senior citizens of Barangay Kaunlaran and there are several spaces therein to conduct livelihood programs and other public purposes;

WHEREAS, Sec. 458 (a) (5) (v) of the Local Government Code of 1991 authorize the Sangguniang Panlungsod to regulate the use of streets, avenue, alleys, sidewalks, bridges, parks and other public places and approve the construction improvement repair and maintenance of the same.
