ORDINANCE NO. SP-**1989**S-2009

**AN ORDINANCE BANNING THE ENTRY OF TEN-WHEELER TRUCKS OR MORE AT ANONAS EXTENSION FROM KALAYAAN ROAD AND FROM KAMIAS ROAD EXTENSION, SIKATUNA VILLAGE, QUEZON CITY.**

*WHEREAS, it has been the request of majority of the residents of Sikatuna Village to ban the entry of ten-wheeler trucks or other similar large vehicle in Anonas Extension from Kalayaan Road and from Kamias Road, Sikatuna Village, Quezon City because they cause harm to the residents and their houses;*

*WHEREAS, Anonas Road Extension is a narrow road thus ten-wheeler trucks or other similar large vehicle should not be allowed as they are dangerous to passerby, houses in the area and small vehicles;*

*WHEREAS, there were reported cases in Sikatuna Village that electrical wires, cable wires, and telephone wires were damaged by the passage of said ten-wheeler trucks;*

*WHEREAS, there are numerous unscrupulous drivers of ten-wheelers trucks passing by slim and narrow streets in Quezon City, thereby endangering the safety of residents and causing massive traffic;*

*WHEREAS, the State, through its Local Government Units, have the right and the obligation to curb certain practices which tend to endanger the safety of the public, as well to provide measures and ordinances aimed at ensuring the safety and welfare of their constituents.*

**NOW, THEREFORE,**


**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:**

*SECTION 1. It is hereby prohibited for ten-wheeler trucks or other similar large vehicle to enter at Anonas Extension from Kalayaan Road and from Kamias Road Extension, Sikatuna Village, Quezon City.*

*SECTION 2. Any person violating any provision of this city ordinance shall be issued an Ordinance Violation Receipt (OVR) by the Traffic Officer concerned or by duly deputized traffic enforcement officer who shall demand the presentation of the driver's license and/or the registration certificate of the motor vehicle. The apprehending officer shall then indicate the name and address of the driver, the license number and the issuing agency of the driver's license in the citation ticket. The name and address of the owner and the registering agency of the vehicle including the certificate of registration number shall likewise be indicated therein. The apprehending officer shall stipulate the specific violation and furnish a copy of the citation ticket to the person apprehended which shall serve as Temporary Driver's License for five (5) days from the date of issuance.*


*SECTION 3. "No Entry" signs shall be posted along the intersections of the aforementioned streets to afford drivers sufficient notice of such restriction.*

*SECTION 4. Repealing Clause. - All Acts, Executive Orders, Rules and Regulations, or parts thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.*
