AN ORDINANCE APPROVING THE ALTERATION OF APPROVAL OF TANDANG SORA PASONG TAMO HOMEOWNERS ASSOCIATION, INC., WITH THIRTY SEVEN (37) LOTS COMMUNITY MORTGAGE PROGRAM (CMP) LOCATED AT LOTS 657-C-3-E-1 AND 657-C-3-E-3, (LRC) PSD-11114, SITIO BACOOD, PASONG TAMO, TANDANG SORA, QUEZON CITY, METRO MANILA, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-277926 AND N-277903 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AGGREGATE AREA OF ONE THOUSAND (1,000.00) SQUARE METERS AS APPLIED FOR BY ITS PRESIDENT, MS.
