ORDINANCE NO. SP- 2136, S-2012

AN ORDINANCE PRESCRIBING MINIMAL RATES FOR THE USE OF VARIOUS RECREATIONAL FACILITIES OF THE QUEZON CITY MEMORIAL CIRCLE.

WHEREAS, Section 458 (a) (2) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

"the Sangguniang Panlungsod shall generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city, xxx and relative thereto shall, (ii) subject to the provisions of Book II of this Code and applicable laws and upon majority vote of all the members of the Sangguniang Panlungsod, enact ordinances levying taxes, fees and charges, prescribing the rates thereof, for general and specific purpose xxx";

WHEREAS, the Quezon Memorial Circle serves as the Quezon City's premiere park and national landmark with facilities that cater to the recreational and sporting needs of the constituents thereof, as well as those of the neighboring cities and municipalities;

WHEREAS, considering the above premises, it is deemed right and justified that those who are benefited by the wholesome atmosphere of the park facilities be made to contribute a minimal amount for its maintenance and stability.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The City Government hereby prescribes the rates of fees for the use of various facilities in the Quezon Memorial Circle, as follows:


SECTION 2. The following are exempted from payment of the herein prescribed fees:

- a). Employees of the Quezon City Local Government using the facilities in line with the city's official sports tournament;
- b). Local athletics sponsored by the government sports organization who would use the facilities of the park for training in preparation for national or regional competitions;
- c). However, Quezon City Government employees may use the basketball and volleyball courts per schedule basis at a discounted rate of P200 per hour from 5:00 p.m. to 7:00 p.m. during weekdays.

SECTION 3. An official receipt shall be issued by the QMC Administration Office for any amount collected for the use of any facilities of the park.

SECTION 4. All proceeds from the use of Quezon Memorial Circle shall revert and accrue exclusively to the maintenance and development fund of the Quezon Memorial Circle.

SECTION 5. The QMC Administration Office shall maintain a book of accounts which shall be under the charge and supervision of its accountant/treasurer. The book of accounts shall be subject to periodic auditing by the City Treasurer or his duly authorized representative. An accomplishment and financial report shall, likewise, be prepared and submitted at the end of each calendar year to the City Mayor and the City Treasurer.




SECTION 6. All disbursements made and proceeds earned by the Quezon City Memorial Circle shall be in accordance with Republic Act No. 7160.

SECTION 7. The QMC Management in coordination with the City Treasurer is hereby tasked to formulate such rules and regulations necessary for the effective implementation of this ordinance.


SECTION 8. If any provision or part hereof is held invalid or unconstitutional, the remainder of the Ordinance or the provisions not otherwise affected shall remain valid and subsisting.

SECTION 9. This ordinance shall take effect upon its approval.
