ORDINANCE NO. SP. 2189 , S-2012

AN ORDINANCE REGULATING THE FLOW OF TRAFFIC BY DESIGNATING CERTAIN STREETS AS ONE-SIDE PARKING AREA, NO PARKING AREA, AND OTHER TRAFFIC REGULATION WITHIN BARANGAY DAMAYAN, DISTRICT 1, QUEZON CITY AND PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall, by virtue of an Ordinance, regulate traffic on all streets and bridges, prohibit putting up of encroachments or obstacle thereon, and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal construction in public places;

WHEREAS, the Local Government Code of 1991 provides further that the Sangguniang Barangay shall submit to the Sangguniang Panlungsod such suggestions or recommendations as it may see fit for the improvement of the barangay or for the welfare of the inhabitants thereof;

WHEREAS, Barangay Damayan, being a commercial-residential area, possess a dense traffic setting where almost all kinds of vehicles traverse therein;

WHEREAS, adding further cause for traffic build-up in said barangay is the fact that some public/government buildings are located within and taxpayers alike seek service provided for by these government agencies.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby declared that One Side Parking from the left side of the following streets in Barangay Damayan:

- 1. San Vicente Street, going to Del Monte Avenue
- 2. San Pedro Bautista Street, from Del Monte Avenue to G. Felipe Street
- 3. San Pedro Bautista Street, from Santos Street to Morato Street

SECTION 2. It is hereby declared that One Side Parking from the right side of the following streets in Barangay Damayan:

- 1. Tolentino Street, from San Pedro Street to G. Felipe Street
- 2. San Vicente Street, from Santillan Street to Zamora Street
- 3. San Pedro Bautista Street, from G. Felipe Street to Santos Street

SECTION 3. The street of G. Felipe from Del Monte Avenue to Morato Street shall be declared as No Parking from five o'clock in the morning (5:00am) to eight o'clock in the evening (8:00pm) in the same day.

SECTION 4. The Department of Public Order and Safety (DPOS) and the Barangay Council of Damayan shall ensure the strict implementation of this Ordinance and are hereby given plenary powers and authority to carry out the provisions of this Ordinance.

SECTION 5. The Department of Public Order and Safety (DPOS) is hereby mandated to install a one-side parking sign on the aforementioned streets to inform motorist and the public in general.

SECTION 6. Any person/s found violating the provisions of this ordinance shall be penalized accordingly pursuant to the Quezon City Traffic Code.

SECTION 7. All existing ordinances, resolutions, executive orders, and rules and regulations that are inconsistent with the provisions of this Ordinance are hereby repealed and/or amended accordingly.

SECTION 8. This ordinance shall take effect upon its approval.
