


ORDINANCE NO. SP- 2280, S-2014

AN ORDINANCE AUTHORIZING BARANGAY DOÑA IMELDA, DISTRICT IV, QUEZON CITY, TO REGULATE THE USE OF STREETS PARTICULARLY GUIRAYAN STREET, KAPILIGAN STREET, AND LUNTAN STREET, ALL LOCATED WITHIN THE SAID BARANGAY.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every local government unit shall exercise the powers expressly granted, x x x and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall, x x x maintain peace and order, and preserve the comfort and convenience of their inhabitants." ;

WHEREAS, Section 458 (a)(5)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Sangguniang Panlungsod to regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon, and when necessary in the interest of public welfare, authorize the removal or encroachments and illegal constructions in public places

WHEREAS, the Barangay Council of Barangay Doña Imelda adopted Barangay Resolution No. 85, S-2012 on December 10, 2012 entitled: "Barangay Resolution Requesting the City Council to Authorize Barangay Doña Imelda to Regulate the Use of Streets Particularly Guirayan Street, Kapiligan Street and Luntan Street Located Within the Barangay.";

WHEREAS, the Barangay Resolution mentioned in the preceding whereas clause emphasized that there is a need to regulate the use of Guirayan Street, Kapiligan Street, and Luntan Street of Barangay Doña Imelda in order to stop and prohibit drivers of public utility jeep to double park their vehicles and prevent the use of these streets as terminals during peak hours to the detriment of commuters and pedestrians, among others;

WHEREAS, in authorizing the Barangay Council of Barangay Doña Imelda to regulate Guirayan, Kapiligan and Luntan Streets, indiscriminate parking of public utility vehicles alongside such streets shall be abated thereby alleviating possible traffic build-up and other causes which shall worsen traffic conditions within these streets.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Barangay Council of Barangay Doña Imelda is hereby authorized to regulate the use of Guirayan, Kapiligan and Luntan Streets for the use of traffic allowing them to prescribe rules therefor. ✕


