SP-1986, S-2009 BY BESTOWING THE TITLE OF "CENTENARIAN CITIZENS" TO THE RESIDENTS OF QUEZON CITY REACHING THE AGE OF ONE HUNDRED (100) YEARS OLD, AND INCREASING THEIR CORRESPONDING FINANCIAL REWARDS TO FIFTY THOUSAND PESOS (P50,000.00), AS ADDITIONAL CASH INCENTIVE.*

WHEREAS, on December 14, 2009, the Quezon City Council approved Ordinance No. SP-1986, S-2009 entitled: AN ORDINANCE GIVING DUE RECOGNITION AND REWARD TO CITY RESIDENTS AGED 100 YEARS OR MORE AS PART OF THE CITY'S EFFORT TO SUPPORT SENIOR CITIZENS\*;


WHEREAS, the said ordinance provides for the following rewards, grants and/or incentives, to wit:

1. SECTION 2 (C) – Upon presentment of proper and authentic documents, the city government will grant each of the centenarian an amount of Ten Thousand Pesos (P10,000.00) cash incentive.

2. SECTION 4 – The centenarians shall be given Christmas gifts and Birthday gifts in the amount of Two Thousand Pesos (P2,000.00) as part of their reward from the Quezon City government in addition to the Ten Thousand Pesos (P10,000.00) cash incentive.

WHEREAS, however, the same ordinance did not provide burial assistance to our centenarians;


WHEREAS, to fully support our centenarians who are the living link to our history up to the time of their demise, and considering the high cost of burial expenses nowadays, there is a need to give additional incentive to them in the form of burial assistance amounting to Fifty Thousand Pesos (P50,000.00). x

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Ordinance No. SP-1986, S-2009 by bestowing the title of "Centenerian Citizens" to the residents of Quezon City reaching the age of One Hundred (100) years old, and increasing their corresponding financial rewards to Fifty Thousand Pesos (P50,000.00) as additional cash incentive.




