ORDINANCE NO. SP- 2390, S-2015

AN ORDINANCE WITHDRAWING FROM RESIDENTIAL USE AND CONVERTING INTO OPEN SPACE EIGHTEEN (18) PARCELS OF LAND OWNED BY THE QUEZON CITY GOVERNMENT, IDENTIFIED AS LOTS 1 TO 17 OF BLOCK-8, AND LOT 1 OF BLOCK-34, CONTAINING A GROSS AREA OF FIVE HUNDRED SEVENTY (570) SQUARE METERS, MORE OR LESS, LOCATED IN BISTEKVILLE-2 HOUSING PROJECT, BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY.
