ORDINANCE NO. SP- **2629**, S-2017

AN ORDINANCE APPROVING SUPPLEMENTAL APPROPRIATION NUMBER 3, GENERAL FUND FOR FISCAL YEAR 2017 IN THE AMOUNT OF THREE HUNDRED FIFTY SIX MILLION THREE HUNDRED TWENTY FIVE THOUSAND AND SIXTY NINE PESOS (PHP356,325,069.00) TO FUND VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES FOR ENVIRONMENT/SANITARY SERVICES.

WHEREAS, on 04 December 2015, Ordinance No. SP-2454, Series of 2015 was approved providing the amount of Sixteen Billion One Hundred Million Pesos to cover for various expenditures to support the operations, programs, projects and activities of the City Government;

WHEREAS, upon the recommendation of the Finance Committee, duly certified by the Local Treasurer, funds are actually available and there is a need to appropriate an additional amount of Three Hundred Fifty Six Million Three Hundred Twenty Five Thousand and Sixty Nine Pesos (Php356,325,069.00);

WHEREAS, the Supplemental Appropriation shall be defrayed to fund various Maintenance and Other Operating Expenses for Environment and Sanitary Services;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
REGULAR SESSION ASSEMBLED:

SECTION 1. APPROPRIATION - The amount of Three Hundred Fifty Six Million Three Hundred Twenty Five Thousand and Sixty Nine Pesos (Php356,325,069.00) is hereby declared as Supplemental Appropriation Number 3, General Fund for Fiscal Year 2017 to be defrayed for the following purposes:

Fund/ Special/ Account: General



SECTION 3. REVIEW - Upon approval hereof, this Supplemental Appropriation shall be submitted to the Department of Budget and Management for Review and Concurrence.


SECTION 4. SEPARABILITY - If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections, part of provisions hereof which are not affected thereby shall remain in full force and effect.

SECTION 5. EFFECTIVITY - This Ordinance shall take effect immediately upon its approval.



