whereas, Section 439 (a), Chapter 10, Book III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every barangay shall in coordination with the Pederasyon ng mga Sangguniang Kabataan at all levels, conduct an annual activity to be known as the Linggo ng Kabataan on such date as shall be determined by the office of the President;

WHEREAS, Presidential Proclamation No. 99 dated November 23, 1992 declared the second week of December of every year as the Celebration of the Linggo ng Kabataan;

WHEREAS, Article 208 and 209 of rule XXVIII of Administrative Order No. 270 prescribing the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991 provides for the observance of the Linggo ng Kabataan and its activities;

WHEREAS, the Pederasyon ng Sangguniang Kabataan ng Lungsod Quezon being a prime youth organization, will spearhead such observance and lined up various activities to realize the objectives of the celebration;

WHEREAS, the Carlos Albert Session Hall is the only venue appropriate for the holding of activities for the Linggo ng Kabataan Celebration;
